#### Summer Reliability: Serving Your Energy Needs in Western Iowa

The North American Electric Reliability Corporation (NERC) released a

report outlining its 2023 Summer Reliability

Assessment in May. In the report, NERC warns that two-thirds of North America is at risk of energy shortfalls this summer during periods of extreme demand.

Many electric utilities across the country are members of one of nine regional transmission organizations (RTOs) and independent system operators (ISOs), also referred to as power pools. These entities are federally regulated by the Federal **Energy Regulatory Commission** (FERC) and work on a regional scale to coordinate, control, and monitor supply and demand on the electric grid. RTOs do not own the power grid, but they work as "air traffic controllers" of the grid to ensure reliable power supplies, adequate transmission infrastructure, and "day-ahead" electric market coordination of wholesale electricity prices on behalf of their members.

NIPCO, WIPCO's wholesale electric generation and transmission provider, owns and operates transmission resources in the Southwest Power Pool (SPP) RTO footprint. While there are no highrisk areas identified in this year's assessment, the number of areas identified as being at elevated risk has increased. The assessment finds that, while resources are adequate for normal summer peak demand, if summer temperatures spike, seven areas — the U.S. West, SPP,

MISO, ERCOT, SERC Central, New England, and Ontario — may face supply shortages during higher demand levels.

The report noted that areas in the U.S. West are at elevated risk due to wide-area heat events that can drive above-normal demand and strain resources and the transmission network. In SPP, the report indicated that wind energy output will be key to meeting normal summer peak and extreme demand levels due to little excess baseload electric generation capacity.

#### What does this mean for WIPCO?

The way we generate electricity is rapidly changing. More and more, renewable energy sources like wind and solar power are coming online, while traditional sources like coal, nuclear and natural gas are being retired. WIPCO believes in and advocates for an "all-of-the-above" energy approach. This "all-of-theabove" strategy reinforces that the U.S. depends on a reliable and sustainable fuel supply that includes developing and incorporating domestically produced renewable energy resources to supplement baseload generation, including biofuels, natural gas, nuclear, hydropower, and coal.

WIPCO, NIPCO, and NIPCO's primary power provider, Basin Electric Power Cooperative, are well-positioned to meet this summer's peak demand. In fact, in 2022, NIPCO's Reliability Factor (the percentage of time for which an average member in the NIPCO system, including WIPCO's members, had normal power conditions and was not subject to any kind of outage conditions) was 99.9905%, and its 5-year average Reliability Factor is slightly higher at 99.9907%. Reliable electric service to our members remains a top priority

for us at WIPCO and our trusted energy providers at NIPCO and Basin.

It's important to remember that our country's electric grid is made up of thousands of generating stations and millions of miles of line. An unexpected power plant outage or natural disaster could impact SPP's projections, and if any such event were to occur, we would communicate this to our members as quickly as possible.

#### What is WIPCO doing?

We will continue to work with policymakers and regulators on the state and federal levels for a sensible "all-of-the-above" generation approach.

The ongoing energy transition must continue to recognize the need for time for technology development while including all energy sources to maintain reliability and affordability. Our families and businesses rightfully expect the lights to stay on at a price they can afford, and a diverse energy mix is essential to meeting these expectations day in and day out.

While we support and encourage the development and use of renewable energy, the intermittent nature of renewables means there may be times when there simply isn't enough energy from renewable sources alone to keep the lights on. This means we must continue to recognize the value of baseload generation plants now and into the future.

Our mission remains the same. We are here to provide safe, reliable, and affordable electricity that is also environmentally responsible. We will continue to advocate on your behalf and do everything we can to continue to live up to this mission.

Kabat Management Internship Program (MIP) is a series of workshops offered by the National Rural Electric Cooperative Association in conjunction with the University of Wisconsin. The program guides participants through all facets of the electric utility industry, including the many changes occurring around the nation.

Akers is one of only a few electric utility management staff that will graduate from the Management Internship Program this year.

MIP participants go through three 10-day sessions designed to challenge and educate in new, innovative management techniques. Participants leave with a better understanding of what consumers want and how to ensure they get it.

By also covering the unique principles that govern the operations of electric cooperatives, the program helps the cooperative analyze other business ventures it may want to enter as well as enhancing the core organization.

Only rural electric cooperative CEOs and toplevel management participate in the program. This allows greater emphasis of study on management and leadership challenges and the aspects of consumer-ownership that cooperatives enjoy. 
District No. 2

#### 6 How to Vote by "Mail-in-Ballot"

The 2023 director election will be held by mailin ballot. Members, please watch for your official WIPCO Election ballot in your mailbox later in July. Each member is entitled to one (1) vote. Also included in the mailing will be the Notice of Annual Meeting, director candidate profiles, a ballot envelope and a return envelope to be mailed or placed in one of our office drop boxes.

Your ballot will be kept sealed and in a secure location until opened and counted by WIPCO's attorney and official ballot counters. It is important that members use both envelopes to maintain the anonymity of the votes.

All ballots returned by close of business (4:00 p.m.) on August 31, 2023, will receive a \$10 bill credit and be eligible in the drawing for an electric grill and bill credits in amounts up to \$50. Members can also vote in person at our District Meeting or Annual Meeting and will receive a \$10 bill credit. 
