### Is a Co-op Career in Your Future?

At WIPCO, we take great pride in powering the lives of our members and empowering the communities we serve. This would not be possible without our group of dedicated

employees, who are committed to continuing to provide the safe, reliable, and affordable power you have come to expect from

your electric cooperative. It takes many different people with many different skills to keep WIPCO running smoothly, and we offer rewarding careers in several areas of expertise.

Many of our employees are lineworkers, and this career path is very in-demand at WIPCO, in Iowa, and throughout the country. Electrical line work offers great pay and fulfilling work, and most post-secondary electrical line work programs can be completed in one to two years. Upon graduation from such a program, most lineworkers will spend several additional years continuing to train in an approved apprenticeship program, such as our apprenticeship program here at WIPCO. However, this training is done on the job, while receiving highly competitive wages and benefits.

We also employ electricians at WIPCO, and the ability to do this work "beyond the meter" is a service we provide to our members that is rare among electric cooperatives. Becoming a certified electrician is similar from a schooling perspective to becoming a lineworker: a relatively short amount of time at a post-secondary school, followed by an on-the-job apprenticeship. The work of an electrician at WIPCO is fast-paced and varied, ranging from in-home wiring and HVAC installation/repairs to work on grain bins and irrigation pivots.

WIPCO and other electric cooperatives also have employees with expertise and training in accounting, graphic design, human resources, engineering, management, customer service, and many other areas. To put it simply, if you or a friend, family member, or loved one has an area of expertise in which you would like to pursue a

career, there is a good chance that a position at an electric cooperative would be a fit!

Careers with electric cooperatives like WIPCO will continue to be in demand well into the future, and we would encourage anyone who is assessing their career options to consider a career in the energy industry. ## Playing it Safe Online



Cybersecurity is the practice of shielding our identities, banking, health records, and sensitive information. Given our growing reliance on internet-connected devices, here are some tips to help you with online safety:

### 1. Enable Multi-Factor

**Authentication:** Add an extra layer of security to your accounts. Even if a hacker has your password, they won't access your accounts without multi-factor authentication.

#### 2. Keep Software Updated:

Regularly update your software from trusted sources to protect your personal data. Beware of fake pop-ups requesting urgent downloads or, better yet, turn on automatic updates.

- 3. Beware of Phishing: Be cautious with emails or texts that seem too good to be true, urgent, poorly crafted, or unusual. Most cyberattacks start with phishing attempts.
- **4. Use Strong Passwords:** Create robust passwords using long, unique, and complex combinations. Consider using a password manager for added convenience and security.

As we prioritize your safety, we also focus on securing our services. WIPCO invests in maintaining and upgrading equipment to withstand weather challenges and utilizes cutting-edge technology to protect against cybersecurity threats.
